**Narrative - Siebrandt, Justin - 2/10/2019 (Initial)**

On 02/10/2018 at approximately 1501, I was advised by dispatch Delta was requesting officers to gate A-9.

Upon arrival, with my body worn camera activated and Officer Haywood's body worn camera active, the captain, later identified as Timothy Hovelsrud, of the aircraft motioned for officers to come his direction. Timothy stated the jump seat in the aircraft, where a flight attendant normally sits, was broken and by legal means the flight attendant has to sit in seat 1C. Timothy continued by saying the gentleman, later identified as Khaled Beydoun, seated in 1C was moved to seat 5C which has just as much if not more leg room than seat 1C. Timothy stated Khaled pulled the "race card" and complained the seat was empty most of the flight. Timothy stated when the plane was deplaning Khaled stated he wanted to talk to the pilot. While Khaled was waiting for his carry-on bag to be brought to him, Timothy stated he would talk to him further up the jet bridge. Timothy stated he motioned for Khaled to come

further up the jet bridge. Timothy said he did not touch him like Khaled is claiming.

I contacted Khaled outside of the A-9 gate at the ticket counter. I asked him to follow me across the terminal to gate A-8 where we could speak to him in private. While walking to gate A-8 Khaled stated he had a question. Khaled advised he was a lawyer and a law professor and wanted to know why officers talked to the captain first and not him. I informed Khaled I didn't know who was involved in the incident. Khaled stated he said "Sir" to an officer as they passed by. It should be noted the only information about the call was that Delta needed an officer to gate A-9. No further information was provided.

Khaled stated he paid for a first class ticket but at the gate in Atlanta he was moved to 5C for no reason. Khaled said might have been ligament or not. Khaled continued by saying he had to sit next to a "large man" and had to effectively sit leaned into the aisle and his "neck" is in pain. Khaled stated he had to sit with his leg stretched out because of his knee surgery. Khaled stated he asked the flight attendant if he could be accommodated in some way then said the flight attendant was rude. Officer Haywood asked Khaled if he knew why he was asked to move seats. Khaled stated he was told a "flight attendant seat might be broken or something." Officer Haywood informed Khaled because the flight attendant seat was broken she was required to sit in seat 1C. Khaled contradicted himself by saying he "understood that."

Khaled proceeded to explain what his second issue was. Khaled stated he was waiting to speak to the pilot in the aisle and the pilot pulled him by his jacket and told him to come here. Khaled stated first it was battery, second it was an assault, and third it was condescending because he was 40 years old. Khaled went back the fact officers passed by him and had a private talk with the pilot deferring to him before speaking with Khaled.

Officer Haywood attempted to ask Khaled if he was a criminal lawyer. Khaled cut off Officer Haywood and stated he was a constitutional law professor. Officer Haywood asked Khaled if it was the officer's duty to get both sides of the story. Khaled agreed it was but wanted to know why his side (Timothy) first. I asked along with Officer Haywood why we should get his (Khaled) side first. Khaled stated why dismiss me. I informed Khaled we did not know who was involved. Officer Haywood asked Khaled if we talk to him first then Timothy could say he felt neglected because we went to him (Khaled) first. Khaled stated "true."

Officer Haywood asked Khaled what he would like officers to do. Since Khaled told officers that Timothy assaulted him Officer Haywood asked Khaled if he wanted officers to get a warrant. Khaled stated "no" he did not want that. Khaled stated he just wanted it documented and he would seek action against Delta. Officer Haywood told Khaled there would be a report taken and in the report it would state Khaled refused any type of prosecution for assault. Khaled agreed. Khaled asked if he could get a copy of the report. I informed him yes it be a few days. I gave Khaled the number for dispatch. I told him to call the number and he would be transferred to an officer and we could email him a copy of the report.

Officer Haywood asked Khaled again if he wanted to press any charges which Khaled refused. I asked Khaled if he was injured in anyway which he stated no. Khaled said he did want to press any charges just wanted it documented.

I spoke with Timothy again in the jet bridge. I asked where he spoke to Khaled at. Timothy pointed toward the front of the jet bridge. I asked Timothy if he touched Khaled which he stated no he is lying. I asked Timothy if he had any issues with him during the flight. Timothy said the flight attendants had issues with him. I told Timothy the flight attendants stated the only issue they had with him is that he wouldn't listen to them.

Timothy stated he played the race card because only white people were in first class and his original seat was empty most of the flight.
