I did not observe Vertical Nystagmus.

I observed the walk and turn test. Mark was then provided the instruction stage and I demonstrated the Walk and Turn Test. I had to tell and show Mark several times the starting position before he was able to do it. Mark had to be told to take his hands out of his pockets. Mark asked if he could do the test with his hands in his pockets and I stated no. Mark lost his balance several times.
